



During the facilitation, 46 Indian startups, 1 incubator, and 1 accelerator have been awarded across 15 sectors. National War Memorial and Merger of Amar Jawan Jyoti

The Amar Jawan Jyoti at India Gate has been merged with the eternal flame at the National War Memorial which symbolizes the gratitude and reverence to brave Indian soldiers who lost their lives in different wars since the independence of India in 1947. The Amar Jawan Jyoti was established to mark the victory of India against Pakistan in the 1971 War and thus got merged into the flame of the National War Memorial, where the names of all these brave soldiers are also got inscribed in golden letters. After the transfer of the Amar Jawan Jyoti to the National War Memorial, a hologram statue of the Netaji Subhash Chandra Bose was also unveiled on his 125th Birth Anniversary to pay tribute to his valuable contributions to the Independence of India.


The Amar Jawan Jyoti at India Gate was established to give tribute to the soldiers who have lost their lives in the 1971 war but there was no impression of their names on the site. The India Gate was built in 1931 by Britishers in memory of 90,000 Indian soldiers in the British India Army who have lost their lives in several British Wars and campaigns before India's Independence and thus was one of the symbols of the colonial past of India.

Besides, the National War Memorial is a national monument to celebrate the victories of India in all the wars after independence and commemorate the soldiers who died and got injured in those wars. This will develop a deliberate connection of these brave hearts with each visitor and will strengthen the feeling of nationhood in future generations. This is the symbol of utmost sacrifice in the nation-building process.

This sacred place has the name of more than 26,000 Indian soldiers of the Indian Armed Forces who have sacrificed their lives for the integrity and sovereignty of their motherland, India. Thus, it is an edifice that develops a sense of belongingness with the sacrifice of our armed forces along with their high moral values for the sake of the nation's pride.

The proposal for the establishment of the memorial was first put forward in 1960 and it took almost 60 years for India, to find this monumental landscape into reality in 2019. It is a homage to all those soldiers who sacrificed their lives in war times as well as in various conflicts, Humanitarian and Disaster Response Operations, United Nations Operations, etc since 1947.

The C-Hexagonal layout structure 400 meters away from India Gate constitutes the National War Memorial, Param Yodhdha Sthal, Canopy, and India Gate in itself. It is also in the structural symmetry of Rajpath and Central Vista. The memorial structure layout has 4 circles with distinct names and impressions:

Being a National Monument, this place will witness various ceremonial functions such as Republic Day on 26th January, Independence Day on 15th August, Kargil Diwas on 26th July, Vijay Diwas on 16th December along with Army Day, Air Force Day, Navy Day, etc.

Thus, the memorial will work as a historical touch point for Indians as well as foreign visitors in the times to come. It will become a connecting thread between our glorious past and our future generations. This will help in nurturing the sense of patriotism and introduce them to the sacred sacrifices made by the Indian soldier's time to time to keep us sovereign and protected.
