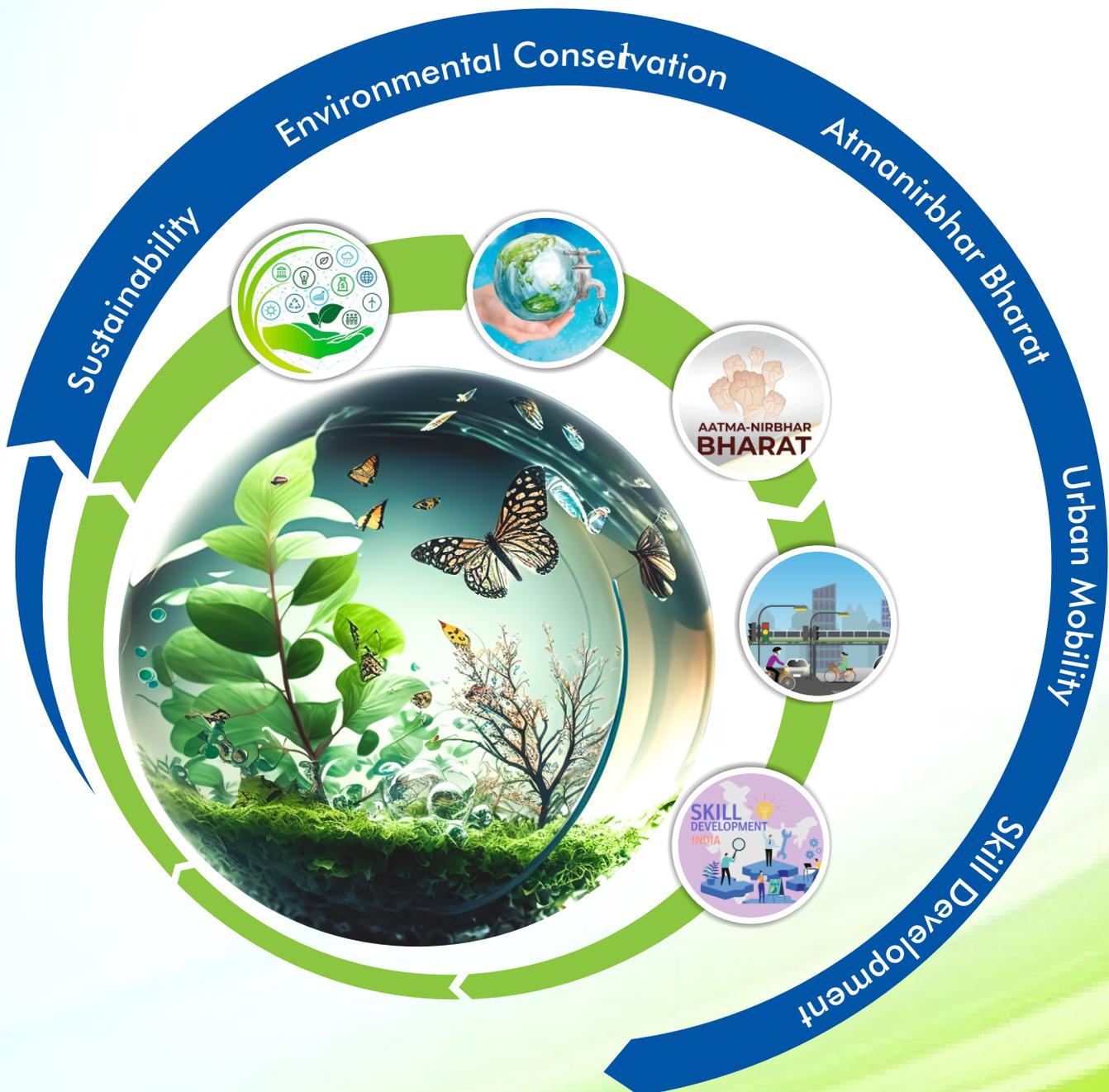

01 | SUSTAINABILITY

Sagar Parikrama Phase- IX to Encourage Sustainable Fishing in India

The Ministry of Fisheries, Animal Husbandry, and Dairying, successfully flagged off Phase-IX of the Sagar Parikrama Yatra on 7th October 2023 for the coastal regions of Tamilnadu and Puducherry. This will highlight and address the issues faced by the fishing community and fishermen across the coastal belt of India. The transformational journey has been planned for three days to facilitate the economic upliftment of fisher folks, fish farmers, as well as stakeholders involved through various government schemes.

India with a long coastline, claims 8 % of total global fish production and thus bagged third position in the world for the same. Around 28 million people in India find their livelihood in the fishing industry while fisheries export occupies a significant chunk of foreign reserve earnings for the Indian economy. In FY 2021-22, the fisheries export in India has been valued at Rs 57,586.48 crore and thus provides impetus to the growth of India's Blue Economy.

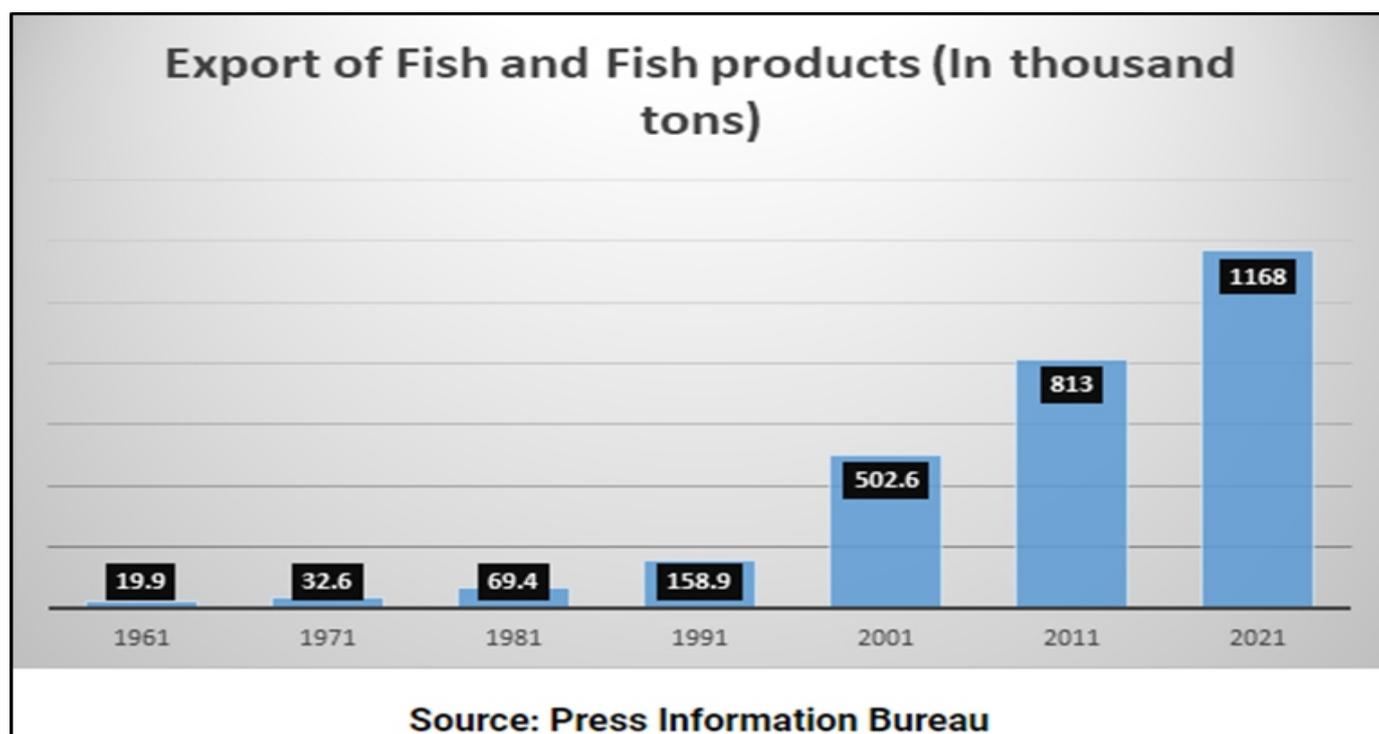
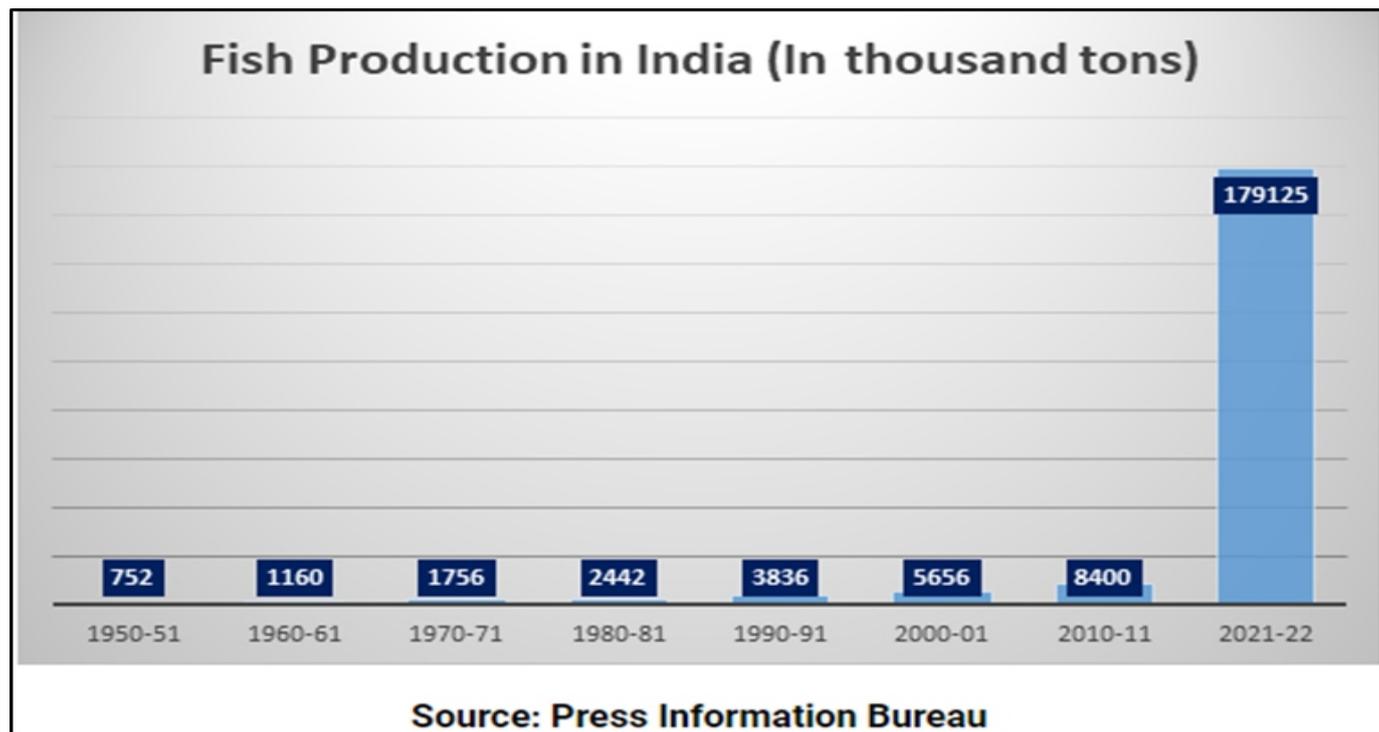
Rs 20,000 Crores for Pradhan Mantri Matsya Sampada Yojana (1/2)

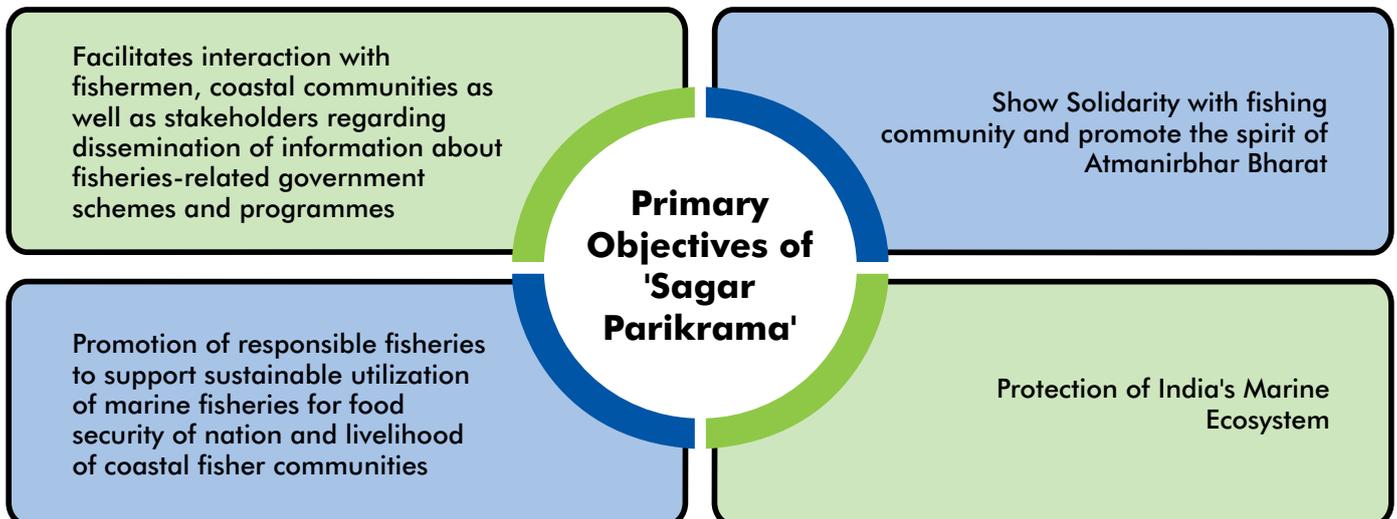

During the Parikrama, the beneficiaries were facilitated with Kisan Credit Cards and Insulated Fish Vehicles along with observing the solidarity with the fishing community and stakeholders through “ Matsya Sampada Jagrukta Abhiyan” on the 2nd day of this mega initiative.



To date, the eight phases of 'Sagar Parikrama' have been completed in the coastal regions of Gujarat, Diu and Daman, Maharashtra, Goa, Karnataka, Puducherry, and Andaman & Nicobar. This initiative along with the highest-ever budgetary support in FY 2022-23 has promised new hopes for the fishing community and gives a major boost to the earnings of stakeholders involved in the complete supply chain including fishermen, fish vendors, and Micro and Small business entities. It will further stand India on the front line of fish and aquaculture production along with increasing export of fish and seafood at the global level.

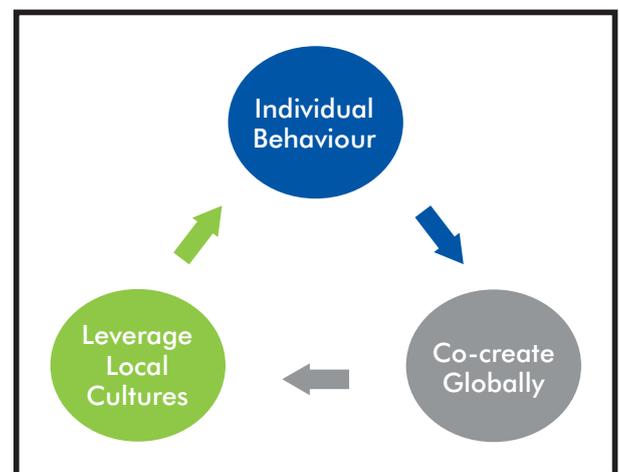
02 | ENVIRONMENTAL CONSERVATION

Green Credit Program and Ecomark Scheme under LiFE Initiative

Recently, to implement the idea of the 'LiFE' Movement- 'Lifestyle for Environment' proposed by the Prime Minister of India in COP26, Glasgow, the Ministry of Environment, Forest, and Climate Change (MoEFCC) notified two major initiatives named 'Green Credit Programme' (GCP) and the 'Ecomark Scheme'. It will help in **replacing the 'use and dispose of' economy with 'circular economy by making eco-conscious practices an integral part of local culture and lifestyle.**

The GCP program will be supported through an inter-ministerial Steering Committee where the Indian Council of Forestry Research and Education will work as GCP administrator and look forward to the implementation, management, monitoring, and operation. **In the beginning, the program will focus on water conservation and afforestation to initiate productive changes.** The 'Green Credit' under the program will be a single unit of incentive allotted to a specific activity for making a positive impact on the environment and that complements the domestic carbon market to meet the environmental obligations to encourage the mindful utilization of available resources.

Approach under LiFE Initiative



Objectives of the Green Credit Programme under the LiFE Initiative

01

It will incentivise environmental positive actions through market-based mechanism and generate tradable green credits.

02

The Green Credit will arise from taking measures by a person of any environment activity referred to in sub-rules (2) of rule 4 such as for the purpose of protection, preservation, and conservation of the environment.

03

The programme will encourage industries, companies, and other entities to meet their existing obligations or other obligations under any law for the time being in force, and encourage other persons and entities, to undertake voluntary environmental measures referred to in rule 4 by generating or buying green credit.

The Green Credits will be allotted to individuals or business entity that takes specific measures in the area of increasing the country's green cover, water use efficiency, water conservation, promoting natural agricultural practices, among many others. The measures can also involve environment-friendly technologies to support the initiatives through various such activities for the protection, preservation, or conservation of the environment.

Along with GCP, the Ecomark Scheme will help to promote consumer awareness and support 'LiFE' principles through the adoption of household and consumer products that promote resource efficiency and the circular economy. It will keep a check on misleading information on products related to environmental protection.

	Prevent misleading and deceptive information with respect to fraudulent use of Ecomark label

These programs under the LiFE initiative will encourage private entities to meet environmental obligations as part of their primary obligations in supporting ecosystem services. This will also serve as an active instrument to receive optimal returns and motivate eco-friendly production while conserving the environment. Thus, the schemes promote a win-win situation for everyone while developing the trading mechanism for green credits in the domestic market with careful assessment and robust standards.

| **ATMANIRBHAR BHARAT****Ministry Notified Changes in Production Linked Incentive Scheme for White Goods**

On 9th October 2023, the Ministry of Commerce & Industry notified changes in the existing Production Linked Incentive (PLI) scheme for which guidelines were originally notified on 4 June 2021. The changes are based on requests/suggestions raised by PLI beneficiaries along with White Goods Industry Associations. The new changes will further increase the ease of doing business in the industry and promote the manufacturing of White Goods in India to further move on the path of "Atmanirbhar Bharat".

Changes Made under the PLI Scheme for White Goods

Adoption of Cost-plus Method in place of comparable uncontrolled price method with an amendment in the definition of 'Arm length'.

Consider Investments in Tool room for manufacturing of Mould & Dies, etc as eligible investment under Capital Investment

Permitting One additional year over and above two years, permitted for informing by beneficiaries about establishment of additional manufacturing facility

Revision of last date of submission of filing the claim and refund of excess incentive by the beneficiary on account of discrepancy between statutory compliance and records provided at the time of filing of claims if any

Site Visit by the Administrative Ministry

Roll over of Bank Guarantee

Appropriate Changes in Annexures to the scheme guidelines

In 2021, the scheme was approved by the Government of India with a total budgetary outlay of Rs 6238 crores for the period of 7 years i.e. between FY 2021-22 to 2028-29 to make White Goods Manufacturing in India, globally competitive. It addresses various issues impeding the growth of the sector, economic scale, as well as efficiency and promotes India as an integral part of the global white goods component ecosystem and global supply chain.

The Indian White Goods industry is promising a bright future with robust growth trends that majorly include ACs, Refrigerators, LED lights, etc. **The industry is expected to cross the US\$ 21 billion mark by 2025 with an expected CAGR of 11%** and promises a significant increase in domestic value addition (more than 75%) by promoting the manufacturing of heavy appliances and household electrical goods.

The revision of guidelines based on industry requirements will further attract global as well as domestic investment in favor of industry growth that will generate large-scale employment opportunities for Indian youths. **It will also substantially enhance India's export share in the global supply chain as both brownfield and greenfield companies' investments are eligible for incentives** under this PLI scheme to support the growth of the White Goods industry of the country.

04 | URBAN MOBILITY

India Welcoming Second Largest Urban Metro System in the World

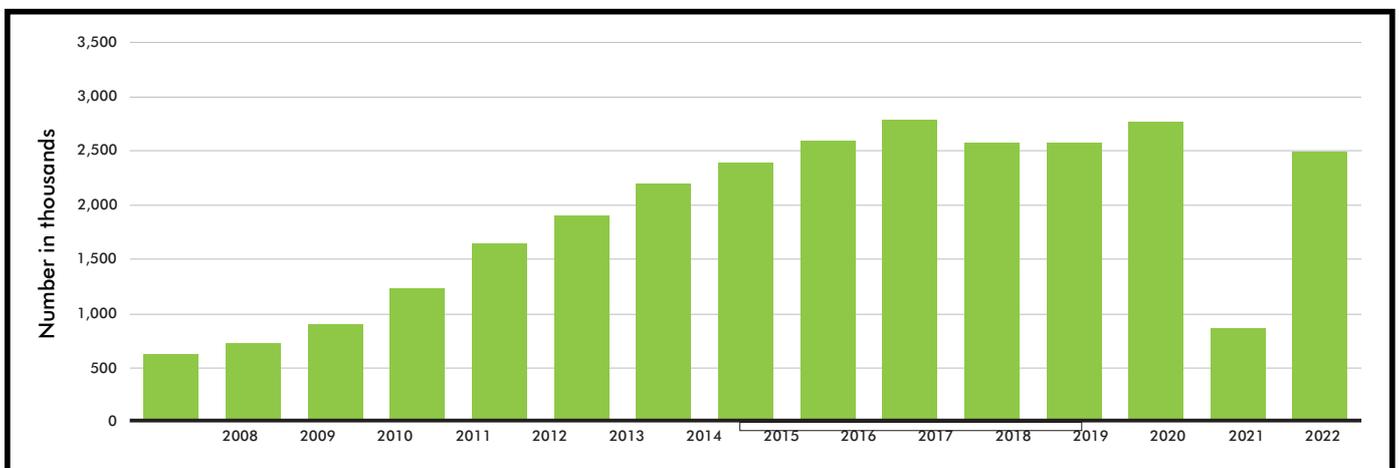
The Ministry of Housing and Urban Affairs launched the XVI Urban Mobility India Conference and Exhibition 2023 and disclosed that India will have the second-largest urban transport metro system in the world in a year and a half. The event took place between 27 October 2023 to 29 October 2023 at the Manekshaw Centre to highlight the promising future of India's Urban mobility choices.

India has witnessed a significant evolution in the area of rapid rail-based public transport systems. The current length of the metro network stands at 895 km spanning twenty different cities in India. According to the MoHUA, **India ranks third position in the world in terms of metro network** and soon, it will grow and overshadow the USA metro network which is currently the second-largest metro network worldwide as under **several new metro lines construction projects country is building around 965 km and once completed it will cover twenty-seven cities instead of twenty cities as on date.**

FY 2008-22: Daily Average ridership of Delhi metro

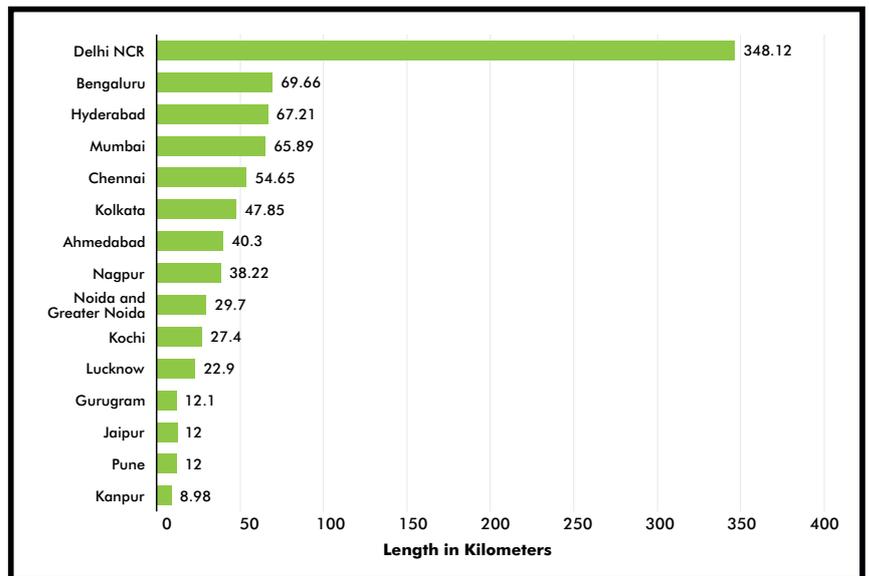

The Urban metro system acts as the backbone for mass intracity commutation in densely populated cities. **As per a 2021 report 2.63 billion people commuted in the metro system annually among the top fifteen cities marking India as one of the busiest hubs for urban metro systems in the world.**

The advancement in the sector has made the metro system a popular preference for transportation by the citizens as it guarantees security, comfort, and stability, carrying about 1 crore passengers daily for the entire operational metro network and is expected to increase. This will make travel faster across diverse destinations due to the constant expansion of the metro rail network marking its global presence.
