





Launch of LiFE Mission and Agni Tattva Campaign

The Prime Minister of India on 20th October 2022 launched its brainchild Mission LiFE "Lifestyle for Environment' at the Statue of Unity, Gujarat which was proposed by him at COP 26 in Glasgow. Its sole purpose is the promotion of a self-sustainable environment-friendly conscious lifestyle among people and thus has been welcomed by global leaders unanimously. The event has been graced by the presence of the United Nation Secretary General (UNSG) who has also highlighted the need for collective efforts for the protection of planet earth.

The LiFE mission encourages people to adopt pro planet lifestyle like reusing waste, adopting LED bulbs, restricting the use of single plastic, limiting the dependency on fossil fuel energy sources, etc through the mantra of Reuse, Reduce and Recycle (3R) for the protection of the environment as well as the future of mankind. The mission highlights the need fora lifestyle that is based on the objective of "Lifestyle of the planet, for the planet and by the planet". He urged the people to be the trustee of this beautiful planet earth and promote a circular economy in place of the 'use-and-dispose' culture. The concept helps to guide individuals to foster the environment and mother nature rather than be exploiters to use the treasure of resources hidden in it.

He also urged global leaders to support the mission and develop a green industrial revolution to promote pro-planet people's behavior for mitigating climate challenges of the 21st century. He also highlighted the urgent need to address the climate change scenario and strong policy-level commitments from global leaders to achieve the climate goals well within their set time lines to reap the benefits.

With rising innovation culture and the support of India's strong political commitment, India's performance and its role in climate protection have also been praised by the UNSG which appreciated its encouraging policies to bring higher public participation. The Prime Minister also thanked 1.3 billion Indians to have trust in India's traditional knowledge and pro-planet lifestyle methods followed for thousands of years to help the country to achieve its committed targets ahead of the time line and lead the world through actions. Some of these milestones are as under:

India's Forest Cover has been increased to 21.71% in comparision to 21.54% in 2017.

The population of Lions, Tigers, Leopards, Elephants and Rhinos are increasing along with Reintroduction of Cheetahs in the Biodiversity.

India's commitment to Achieve 40% installed Electric Capacity from Non- Fossil fuel based energy Sources has been achieved 9 Years ahead of Schedule.

The targeted 10% Ethanol Blending Traget in Petrol has been Achieved 5 months earlier than scheduled target of November 2022 with respect to availability of 5% blended Petrol in 2019-20.

As per the Renewables 2022 Global Status Report 2022 by Renewable Energy Policy Network for the 21st Century (REN21), India's rank in Renewable Power Installed Capacity is third.

The encouraging outcomes over time have been achieved by India through the promotion of innovation and openness across the sectors. The beautiful blend of traditional ancient knowledge with advanced technology is paving the way for India's pro-planet sustainable growth and leading the world to eliminate greenhouse gases (GHGs) and live zero carbon lifestyle with collaborative actions.

A month earlier to the launch of this mission, the Union Minister of Power and Renewable Energy launched the campaign on Agni Tattva which is one of the five powerful elements of Panchmahabhoot. The campaign is to highlight the importance and create awareness about "Energy" (Agni Tattva) for Mission LiFe and make people aware of the core concept of this element beside the other four from Panchmahabhoot i.e., Earth (Prithvi), Water (Jal), Air (Vayu) and Space (Aakash).

The conference was kick-started with the theme of "Sustainability and Culture" in Leh and has appreciated the role of the Ladakh administration for effectively implementing a clear roadmap to settle

the environmental imbalance towards the sustainable development of the region as a model of sustainable lifestyle choices for the country as well as the globe. It has harnessed the interest of all the stakeholders including policymakers, startups, innovators, researchers, academics, etc working in the field of energy, culture and sustainability.

Thus, the campaign has created momentum to encourage people to adopt a lifestyle that will be in harmony with nature and help the country to fulfill its commitment regarding sustainable development and climate change. The campaign has set the path to work in interdependency and coexistence for a sustainable future through the evolving renewable energy landscape that will create a green and safe environment for one and all.



India Semiconductor Mission

Recently to provide a major boost to India Semiconductor Mission (ISM), on 17th October 2022, the Ministry of Electronics & Information Technology started the first Semicon India Future Design Road show with the theme of 'Catalyzing the Next-Generation Semiconductor Design Start-ups' from Gujarat.

These events will help to energize the startups working in the area of Semiconductor Design and innovation to tap the incentive benefits under the Design Linked Scheme of ISM which was launched by the Government of India in 2021. The vision was to establish India as a Global Hub in the domain and emerge as a leader in the Semiconductor design and electronics manufacturing sector by following four broad schemes to facilitate infrastructure growth for the industry and setting up the enabling specialized ecosystem:



ISM functions as a Special Independent Division under Digital India Corporation for building a robust semiconductor and display ecosystem in the country with a comprehensive, coherent and efficient deployment framework for the program in association with the Central ministries, departments, agencies, industry as well as academia.

The mission functions in the advisory matters for the growth of the industry and attracts public, private and global investments for the same. All the government schemes related to the promotion and support of the semiconductor industry such as manufacturing, display fabrication, etc are also implemented through ISM. It has all the necessary powers to effectively achieve the objectives of the mission or as directed by the Ministry of Electronics and Information Technology from time to time.

The mission with Rs 76,000 crore incentive outlay is aimed to attract major investment in this strategically important sector with the setting up of the Semicon city in India at Dholera, Gujarat which will eventually establish India as Asia's hub for 'Electronics & Semiconductor Innovation'. In the last 7 years, the country had seen unprecedented growth in the Electronics sector and touched a record Rs 27,000 crore mark in 2019-20 which was almost zero in 2015-16.

Semiconductors are the building block of Electronics and Information Technology and thus broadening their manufacturing capabilities within the country is critical as well as important. The mission in this

regard is going to give the impetus to its growth and help India to expand its digital economy and touch the mark of US\$ 1 trillion by 2025-26. For this, the major objectives outlined under the mission are:

Formulation of Comprehensive Long Term Strategy for Sustainable Semiconductors display manufacturing and design ecosystem in India

Facilitation and Development of Secure Microelectronics and trusted Semiconductor Supply Chain

Enable Multifold Growth of the Semiconductor Design Industry through Support Mechanism

Promotion and Facilitation of Indigenous Intellectual Property (IP) generation

Encourage, Enable and Incentivize Transfer of Technlogies in the domain

Establishment of Suitable measures for scale of the Economies in the Industry

Enable the Cutting-edge Research in the industry through Grants, Global Collaborations, Establishing Center of Excellence and other Mechanisms

Catalyze the Collaborative Research, Commercialization and Skill Development through National & International Collaborations and Partnerships

ISM works as a nodal agency to drive financial support in semiconductor display manufacturing and design units while strengthening the ecosystem. To completely envision the objectives of Atmanirbhar Bharat and ISM, India needs to reenergize the growth ofits electronics manufacturing and innovation capabilities with the help of global experts and tap the strength of India's vibrant startup ecosystem to make a global presence.

Today, technology is all around and everyone's lives are revolving around electronic gadgets like smartphones, laptops, etc. The semiconductor is the heart of these electronic devices including various medical equipment. Thus, during the Covid 19 when the global supply chain went on to stand still, the challenges of this industry increased many fold.

As per the estimates, India's domestic consumption of semiconductors is going to cross the US\$ 100 billion mark by 2030 and thus to develop a steady and reliable supply chain to address such challenges in the future, India needs to develop its semiconductor industry in a mission mode and get the early bus to reap the optimum benefit.

Thus, to tap the enormous opportunity in the next phase of India's digital transformation with Industry 4.0, the development of semiconductor and display manufacturing is the driving force. India needs to set a big aim to emerge as a key player in the global semiconductor ecosystem to play a critical role in deriving favourable trade policies that can establish India as one of the emerging dominant players in the semiconductor global supply chainsoon with strong policy support and effective implementation mechanism under the ISM.

ANALYSIS REPORT ON INDIA'S NATIONAL HIGHWAY INFRASTRUCTURE





Overview

India being home to one of the largest populations in the world, needs a vast road network for its socio-economic growth. The road network is the lifeline of the country as almost 65% of the goods transportation and around 90% of passenger traffic in India move through this complex mesh. They are the one who connects the farthest corners of the country and helps in the interstate movement to support regional growth beyond enormous disparities.

Over time, the importance of the National Highways (NH) has increased due to the heavy load on roads and to provide safe, secure, as well as time-efficient travel for personal and commercial needs. It provides a secure environment to commuters in the form of broader roads, interconnected ways to adjoining cities and towns with precise specifications and facilities such as multiple lanes with clear signboards, dedicated carriageways, electronic toll plazas, controlled access at crossroads along with medical and public utilities.

In India, only 2% of the construction of the total road network comes under the NH but this small proportion carries around 40% of India's total traffic. In the last 7 years, national highway construction has seen a major surge looking at the rising number of vehicles making congestion on roads and to fulfill the need for an improved supply chain for India's logistic sector. As per the government statistics, in FY 2020-21, a total of 13,327 km of NH construction took place in comparison to the NH construction of 4,410 km in 2014-15.

As these are the primary roads that interconnect major cities and industrial hubs with each other, the Central Government sees the development and maintenance of these NH through its dedicated agency for the purpose National Highway Authority of India (NHAI). Currently, some of the national highways or expressways are made equipped with airstrips also to play a strategic role in times of need.

The Government of India through special attention on India's road infrastructure is bringing a transformational shift in highway construction through policy initiatives such as the Gati Shakti Master plan, Bharat Mala Pariyojna, Dedicated Freight Corridors, etc as to achieve the target of constructing National Highway Network of 2 lakh Kms by 2025. For this, the provisions have been made under the Union Budget 2022-23 and the projections are to receive significant outlay in the successive budgets also as these are the important pillars of national growth as well as national security and prosperity.

India is developing the highway infrastructure through a developed framework of the Public Private Partnership (PPP) model. International institutions such as Asian Development Bank are also providing financial support to extend its highway infrastructure. Other than this, the 100% FDI allowed in the road

and highway sector in India under the automatic route is also bringing lots of investment to fuel up the energy in the domain and promise a bright future for all the stakeholders.
