NITI Aayog Organizes Workshop on 'Green Development Pact for Sustainable Future' Around G20 New Delhi Leaders' Declaration

The 'Green Development Pact (GDP) for a Sustainable Future' workshop was conducted on 09 November 2023 in New Delhi and was organized by the NITI Aayog with the Council on Energy, Environment, and Water (CEEW). The objective of the workshop was to collect a deep understanding of GDP on practical grounds, to be implemented successfully as mentioned in the G20 New Delhi Leaders' Declaration (NDLD). The GDP is a pathway for gaining climate, disaster, environmental conservation, and energy bounce back ability for the nation to achieve a sustainable future globally.

Insights from Workshop

The workshop discussed actionable strategies for GDP along with G20 NDLD

The workshop was witnessed by 4600 members online including central and state government, education institutions, think tanks and industries.

The Ministry of Power announced policies for boosting green development.

Scheme launched under policy initiatives are PLI scheme, CCTS (Carbon Credit Trading Scheme) scheme and Renewable Purchase Obligations scheme.


Measures for nourishing distribution sector like Revamped Distribution Sector Scheme were highlighted.

GDP aims to triple renewable energy by 2030 at global level.

GDP estimates to achieve trillion dollar market by boosting climate finance.

Green development not only focuses on green energy but also affordability and efficiency followed by lifestyle changes to achieve sustainability through viable methods. The workshop consisted of three sessions aiming to sync with NDLD guidelines to address diverse issues. They highlighted the need for implementing viable, clean, just, and low-end full green energy transition shift, issues of having a seasoned ecosystem, energy security, boosting innovation, and promoting technology reach to overcome low-cost funding and inclusive supply chains.





Addressed ecosystem-driven restoration, conservation, and sustainability, and issues like LiFE-driven sustainable development, building a circular economy, and ceasing plastic pollution. Futuristic ideas were exercised encouraging self-initiatives, bio-based circular green economy, and eliminating misunderstanding and miscommunication between individuals/groups to unite them.

Challenges associated with Adaptation and Disaster Resilient Infrastructure were discussed suggesting the creation of viable infrastructure to handle the impact of climate change risk, pollution, and biosphere loss. Ministry of Petroleum & Natural Gas Revolutionizing e-Mobility Paradigm with India's First Green Hydrogen Fuel Cell Bus


The Union Minister of Petroleum & Natural Gas and Housing and Urban Affairs flagged the first Green Hydrogen Fuel Cell Bus on 25 September 2023 at Kartavya Path in Delhi to promote e-mobility towards achieving a sustainable ecosystem with the help of green energy.



Green hydrogen has the potential to play a significant role in having low-carbon and self-sufficient financial pathways. It can utilize the renewable energy resources available in the country in enormous amounts across diverse regions, sectors and seasons. It can be used directly as a fuel or raw material in the industries being used for different purposes. It can replace fossil fuel-extracted raw material in sectors of steel manufacturing, petroleum refining, fertilizer production etc.



In the field of e-mobility, Fuel cell technology is witnessing a rising trend. The advanced research states that Hydrogen is a valuable element that can be used as Fuel Cells. Fuel cell technology is regarded as one of the most efficient choices available in the e-mobility sector. Vehicles running on hydrogen fuel cells have the inbuilt advantages of higher running range and minimized refuelling time in comparison to battery-operated e-vehicles.



The trial will study the collected data and aggregate mileage of more than three lakh km for the assessment of durability and performance in the long run to support the future of hydrogen-based zero-emission transportability in India. Key Findings for the Indian Economy




The IMF in its October 2023 edition report revealed that India is one of the top-rated emerging economies performing better than expected, and regarded as one of the fastest developing economies in the world. The report states the expectation that the country can become 3rd biggest world economy with a GDP of around 5 trillion US dollars by 2027.

According to the IMF, annual announcement through the WEO release forecasts India's raised GDP growth for the year 2023-24 to 6.3% cent. The country is expected to retain its growth at 6.3% cent for 2023 and 2024 witnessing a rise of 0.2% cent for 2023 because of high consumption demand during April 2023 to June 2023 the first quarter of the FY 2023-24. In the July 2023 forecast, the IMF estimated GDP forecasts for India at 6.1% cent but it was found to be lower

than the RBI estimate of 6.5% cent for FY 2023-24. Here India's growing economy and its prospects can be boosted through revised FDI norms, structural reforms, a seasoned workforce, and a strong financial system.


Regional Economic Outlook: Asia-Pacific Highlights



IMF forecasted a rise to 4.6% cent in 2023 from 3.9% cent in 2022 and Asia's growth will witness a slowdown to 4.2% cent in 2024.

The growth of the Indian economy is due to enhanced consumption, the PLI scheme to promote manufacturing across the sectors, the setup of new employment streams, and the upscaling of infrastructure sidelined by the warning of slowness caused by geopolitical pressure and rising inflation.

Chandrayaan 3 and India's Quest to Search Life Beyond Planet Earth



India has finally taken its victory walk on the moon through Pragyan Rover under the ISRO's Chandravaan-3 mission. On 23 August 2023, the world witnessed India's glorious space power when Chandrayaan 3 Vikram lander safely landed on the unexplored south pole of the moon and changed the old saying 'Chanda Mama Door Ke'.

This unmatched success has made **India the frontrunner in future space missions alongside Russia (then USSR), the USA, and China**. It will be going to bring a new change in identifying the possibilities of life on the moon and bring future successes for humanity at large.

Chandrayaan 3 has three broad objectives to find life on the southern pole of the moon to which the safe soft landing was the first phase and was achieved successfully with the rolling out of Rover on the moon surface. The rover will now be conducting in-situ scientific experiments in 1 lunar day (14 days on Earth) that include near-surface plasma density, associated changes, thermal properties in nearby regions, structure of lunar crust and mantle, seismicity measurement to understand the unknown dynamics of Moon System.

This will promise new qualitative as well as quantitative data analysis that can further help scientists investigate probable scenarios for the existence of life on the moon. India's discovery is big in terms of historical, scientific, and geological reasons as this will study in detail India's further discovery of Water at the southern pole. It will bring new power to future space missions as it may work as a source of fuel for rockets and spacecraft sent on space exploration for future missions.

The Chandrayaan 3 with a cost of US\$ 75 million, is exploring the prerequisites of life (oxygen, fuel, water) on the unexplored southern pole of the moon to find possibilities of space travel and a permanent habitat for mankind. The Chandrayaan 3 success will now give a major boost to the future missions of ISRO such as Aditya L1 to study the Sun i.e. about 1.5 million km away from Earth and Chandrayaan 4 (jointly with Japan Aerospace Exploration Agency) to fulfill India's continuously increasing space quest to find answers of unexplored facts.
