

ASIA Japan Slips to the World's 4th Largest Economy Rank

Japan's economy till 2010 was the 2nd largest in the world later it was overshadowed by China. Unfortunately under the looming threat of economic recession, Japan's economy has further slipped by 1 position and at present it is securing the 4th largest economy ranking of the world after Germany. Japan's Economy has shrunk to 3.3% and 0.4% in the 2nd and 3rd quarters of 2023 resulting in the weakening of the Yen against the US Dollar. Japan's nominal GDP for 2023 was 4.2 trillion USD against Germany's 4.5 trillion **USD** as per government data. The core reasons encountered are reduced consumer buying capacity and trade investments amid the January 2024 earthquakes in western Japan which is the manufacturing hub of the country. The rise in corporate profits resulted in the increased price of goods but not the income resisting buying sidelined by the falling population. The central bank has to amend its policies to combat recession. To regain Japan's lost ranking, the government has to reshape its strategies and policies to boost adaptability and ensure wealth infusion.



US Ban's Al-generated Robocalls to Stop Scams Involving Voice Cloning

The Federal Communications Commission (FCC) has banned the robocalls produced using AI-generated voices under the Telephone **Consumer Protection Act** (TCPA). Restricting the misuse of AI technology will minimize consumer scams, celebrity imitations, and most recently acts of misleading voters, compromising privacy, and financial loss. Scammers with the help of advanced AI, create authentic voice clones used to influence targets for retrieving private & sensitive information or executing financial transactions. The FCC ban will enable the concerned authorities to spot these fraudsters to face lawbound charges and penalties. The regulatory authority has to remain watchful for the protection of consumers from such fake robocalls. It will be a milestone step as technology is evolving rapidly and its fair use needs to be ensured through effective implementation.

Sweden has historically been in favour of military nonalignment for decades. But now, it decided to become part of the largest military alliance in the world i.e. the North Atlantic Treaty Organization (NATO). Russia invaded Ukraine compromising security guarantee of Sweden. After Hungary's approval on 26 February 2024, Sweden became the 32nd member of NATO, and soon flag-raising will take place at NATO HQ in Brussels. Geographically, it will strengthen control of the Baltic Sea broadly termed as the NATO sea impacting the shipping route for Russia . Sweden's NATO alliance is a significant move for safeguarding its national security in the Europe region amid the changing geopolitics and global

The objective is to have a balanced employer-employee relationship underlined by fair working conditions and neutrality at the workplace. Proposed changes in the bill are expected to create a better working ambience driven by transparency, equality, and fairness maintaining a healthy environment at the workplace. It will also empower the commission to provide general protection. The changes introduced will be implemented in phases during this and next year.
