1 OVERVIEW

The seventeenth BRICS Summit, held in Rio de Janeiro on July 6-7, 2025, brought together major emerging economies to address key global challenges. The theme of "Strengthening Global South Cooperation for a More Inclusive and Sustainable Governance" highlighted the current geopolitical and economic realities, with member countries working together under Brazil's leadership to reinforce South-South cooperation.





The 2025 summit strengthened BRICS' role as a collective representative of emerging economies. It highlighted a shared commitment to deepen cooperation and foster a fairer international order.




2 | HISTORY OF BRICS AND MEMBERSHIP

BRICS originated in the early 2000s as a term to describe four rapidly growing economies: Brazil, Russia, India, and China. Economist Jim O'Neill introduced the acronym in 2001 to highlight their economic potential.

The nations started informal discussions in 2006 and formalized their partnership at the **inaugural** summit held in Russia in 2009. Their main objective was to shift global power dynamics away from Western dominance while creating new opportunities for worldwide development.

South Africa became a member in 2010, expanding BRIC into BRICS. Together, the bloc, **as of 2025**, **account for about 40% of the world population and contribute nearly 41% of global GDP**. This highlights their significant influence on international trade, development, and financial systems.

3 ECONOMIC ANALYSIS **AND TRENDS** WITHIN BRICS

At the 2025 BRICS Summit in Rio de Janeiro, the focus was sharply on advancing economic cooperation through strategic integration and innovation. Leaders emphasized the "Strategy for BRICS Economic Partnership 2025," aimed at enhancing trade facilitation, financial integration, and sustainable development aligned with global economic frameworks.

A significant trend discussed was strengthening climate-resilient infrastructure. The **BRICS Payment Task Force prioritized mitigating exchange rate risks and creating investment-ready projects** to attract private capital, boosting economic stability across member states. Expansion and resource mobilization of the **New Development Bank** were highlighted as crucial to funding green infrastructure and promoting local currency financing to reduce reliance on major reserve currencies.

India highlighted the crucial role of digital technologies in promoting inclusive growth and expanding financial access. **Indian initiatives in fintech and digital payments platforms were noted as models for broader BRICS cooperation.** The country also advocated for resilient supply chains and accelerated reforms in international financial institutions to better serve emerging economies.

Additionally, supply chain resilience and responsible governance of artificial intelligence were key topics. The summit advanced the **BRICS Framework Declaration on Climate Finance and AI, proposing a Multilateral Guarantees scheme** to improve infrastructure investment risk management.

Thus, the summit reflected a collective push toward modernizing financial mechanisms. **Leaders championed sustainable projects and embraced technological advancements.** These initiatives are designed to strengthen economic progress and enhance collaboration among BRICS members.



4 | POLITICAL AND GEOPOLITICAL INFLUENCE

The 2025 BRICS Summit highlighted the bloc's growing political and geopolitical influence, focussing on strengthening global governance and enhancing South-South cooperation. The member countries called for urgent reforms in international institutions, such as, the United Nations Security Council and the International Monetary Fund, to better represent emerging economies and address contemporary global challenges.

India emphasized the need for greater inclusion of developing countries in global

decision-making processes. It stressed the importance of safeguarding national sovereignty in digital governance and advocated for transparent and accountable international institutions. India also emphasized fair climate finance and equitable access to innovation as priorities.

Under Brazil's presidency, the summit adopted 126 commitments on different strategic topics. The "BRICS+ Dialogue" was launched to expand diplomatic engagement by involving important partners from Africa and Latin America. This move supports the bloc's goal of fostering a multipolar world that balances existing power relations and encourages greater political cooperation among emerging economies.



On international conflicts, BRICS adopted a cautious and balanced approach, encouraging multilateral dialogue and peaceful resolutions rather than confrontation. The summit also endorsed ethical guidelines on artificial intelligence and responsible climate finance, reinforcing BRICS's commitment to shaping global standards.

5 | SECTORAL COLLABORATION AND INITIATIVES

The 2025 BRICS Summit prioritized sectoral collaboration across multiple key areas, introducing innovative initiatives to foster development and cooperation among member countries. Health cooperation was a major focus, with commitments to strengthen global health governance, promote equality, and support the elimination of socially determined diseases, addressing disparities linked to poverty and social exclusion. This reflects BRICS's shared acknowledgment of health as a cross-border challenge requiring collective action.

In line with health priorities, the bloc emphasized joint strategies to **improve access to healthcare technologies and vaccine distribution**, aiming to build resilient health systems among member nations. Collaborative research and development initiatives were encouraged to tackle pandemics and other health emergencies effectively.

In industry and technology, the summit advanced the "Partnership on the New Industrial Revolution" (PartNIR), designed to boost industrial collaboration in advanced manufacturing, digital transformation, and robotics. New working groups on intelligent manufacturing, digital industry, and small and medium enterprises (SMEs) were formalized, along with a plan of action for SME cooperation from 2025 to 2030. The establishment of the BRICS Centre for Industrial Competences, in partnership with UNIDO, supports upskilling and productivity enhancement in Industry 4.0 technologies.

This platform aims to connect startups, investors, and incubators to foster growth, innovation, and sustainable business practices across the bloc.

6 INDIA'S ROLE AND CONTRIBUTIONS **IN BRICS**



India also prioritized sustainability issues within BRICS. It advocated for joint initiatives on climateresilient infrastructure and renewable energy projects. India's emphasis on collaborative environmental solutions underscored its commitment to addressing shared challenges such as water scarcity and clean energy, which are vital for the long-term development of member countries.

Digital governance emerged as a key area of India's contributions. At the summit, India promoted the creation of interoperable digital public goods. This approach supports secure data sharing, digital identity frameworks, and financial inclusion across BRICS nations. **India emphasized the importance of cybersecurity, data privacy protections, and fostering innovation ecosystems**, reflecting its broader digital transformation agenda and its push for technology-led development.

Cultural and academic cooperation were other areas where India played an important role. By encouraging exchange programs and joint research efforts, India sought to deepen mutual understanding and trust among BRICS countries. Lastly, India emphasized the importance of social inclusion at BRICS 2025, particularly focussing on gender equality and youth empowerment. It supported programs to foster entrepreneurship among women and young people across member states. These initiatives align with India's broader vision of inclusive growth and reflect its ambition to make BRICS a platform for equitable development and shared progress.

7 ADVANCING INDIA'S ECONOMIC POTENTIAL AND STRATEGIC REACH AT BRICS 2025

The BRICS 2025 Summit offered significant economic and strategic benefits for India, enhancing its position in global trade and diplomacy. A central outcome was the commitment to facilitate trade by reducing barriers and promoting localcurrency settlements. This approach aims to minimize transaction costs and reduce exposure to international financial shocks, directly benefiting Indian exporters and investors. The summit's Rio Declaration reinforced continuity within existing BRICS trade frameworks, fostering a favorable environment for India's market access.

On financing, India gained from initiatives linked to the New Development Bank focussed on risk mitigation and project de-risking. These measures are expected to lower borrowing costs for Indian infrastructure and green energy projects, thereby supporting domestic investment growth. India also advocated for better regulatory alignment among BRICS nations, which could help Indian companies access diverse funding sources beyond traditional Western channels.

Strategically, the summit expanded India's engagement with key energy suppliers and Global South nations, boosting India's energy security and diplomatic influence. The growing membership and partnership programs allow India to cultivate coalitions on specific issues without compromising its broader international relationships.

Significant progress was made on standards and governance, especially regarding digital economy, artificial intelligence, and trade facilitation. These align closely with India's digital ecosystem and create avenues for exporting digital public infrastructure, scaling fintech, and enabling secure cross-border data flows. Such frameworks provide predictability, benefiting India's tech industry and skilled workforce mobility.

8 CHALLENGES AND CRITICISMS AMONG **BRICS MEMBERS**


The BRICS 2025 summit exposed several challenges and criticisms that threaten the bloc's united front. One major issue is the **diversity of political systems within the group, ranging from democracies like India and Brazil to authoritarian regimes such as China and Russia**. These differences complicate consensus-building on governance, human rights, and international norms, often leading to divergent policy approaches and hindering unified stances.

Economic imbalances within BRICS also generate tensions. China's dominant economy overshadows other members, fuelling concerns about Beijing's disproportionate influence, including its economic practices and debt diplomacy. Moreover, intra-BRICS trade remains relatively low despite ambitions for economic integration, partly due to tariff barriers and competition between members with conflicting priorities.

Geopolitical rivalries further complicate cooperation. The longstanding India-China border dispute and intensified competition for leadership of the Global South breed mistrust. The recent expansion of BRICS added members with their own regional conflicts, such as Saudi Arabia and Iran, adding

layers of strategic friction. These rivalries make coherent foreign policy coordination difficult.

Critics also point to BRICS's informal structure as a weakness. Without a permanent secretariat or binding treaty, the group struggles with institutional coherence and consistent implementation of decisions. **The lack of common currency or unified financial mechanisms hampers deeper economic integration**, limiting the bloc's capacity to challenge global governance dominated by Western powers.

Overcoming these challenges is essential if BRICS is to evolve beyond symbolism and become an effective force shaping the future global order.



9 WAY FORWARD

The 2025 BRICS Summit charted a clear path forward, emphasizing deeper economic integration and sustainable development among member countries. The bloc aims to enhance trade, investment, and digital cooperation, especially supporting MSMEs to foster inclusive growth.

A key focus is climate finance. The summit introduced the BRICS Climate Finance Framework, promoting investments in renewable energy and environmental resilience. This underscores the group's commitment to balancing economic expansion with environmental responsibility.

Reforming global governance remains a priority. BRICS members called for changes in institutions such as the UN Security Council and IMF to better represent emerging economies. Strengthening multilateralism and cooperation on global challenges, including pandemics and digital governance, is also critical.

The launch of the BRICS Multilateral Guarantee Mechanism signals a move toward actionable initiatives. Pilot projects in 2026 will mobilize private capital for infrastructure and sustainability projects, reducing investment risks in member and partner countries.




10 EXPERT INSIGHT
