



India Hosts Landmark Second WHO Summit on Traditional Medicine

India hosted the **Second WHO Global Summit on Traditional Medicine** from **17 to 19 December 2025 in New Delhi**, reinforcing its role in advancing holistic healthcare worldwide. The three-day Summit, under the theme "Restoring Balance: The Science and Practice of Health and Well-Being," brought together health leaders, researchers, traditional medicine practitioners, and policy representatives from over 100 countries. The event focussed on strengthening **traditional, complementary and integrative medicine (TCIM)** with a foundation in scientific evidence, sustainability, accessibility and global cooperation.

Organized jointly by the World Health Organization (WHO) and the Government of India, the Summit built upon the momentum generated during the first Traditional Medicine Summit in 2023. A major focus was the **implementation of the WHO Global Traditional Medicine Strategy 2025–2034**, a framework designed to guide countries in safely integrating traditional medicine into mainstream healthcare systems. Sessions highlighted the need for standardized regulations, quality assurance, clinical validation, digital documentation and collaborative research ecosystems to support large-scale adoption.

One of the most significant outcomes of the Summit was the **launch of the WHO Traditional Medicine Global Library, the world's first comprehensive digital repository dedicated to traditional medicine knowledge**. The platform hosts over 1.6 million scientific records, regulatory guidelines, research papers and Indigenous medicine documentation. The library is envisioned as a tool to support policymakers, researchers and health systems in building culturally relevant and evidence-aligned medical frameworks.

The Summit also facilitated structured international engagement, with India conducting **bilateral discussions with 16 countries on future collaboration** in traditional medicine. These dialogues covered areas such as regulatory harmonization, research partnerships, intellectual property protection, biodiversity-linked medicinal knowledge, capacity building and innovation frameworks. The cooperation highlighted the importance of long-term multilateral partnerships beyond the Summit itself.

KEY COMMITMENTS FROM THE SUMMIT

- 1** Strengthening the evidence base for traditional medicine
- 2** Supporting equitable access to safe and effective traditional medicine through appropriate regulatory mechanisms
- 3** Integrating safe and effective traditional medicine into health systems
- 4** Optimizing cross-sector value through data, collaboration, and empowered communities

The Summit underscored that TCIM must evolve alongside modern healthcare through **rigorous scientific benchmarking, responsible commercialization, ecosystem protection and technology-driven knowledge preservation**. Thus, India's successful hosting of the event signals a shift toward globally aligned integrative health solutions, strengthening India's contribution to building resilient, sustainable and inclusive global healthcare models.

India Scripts History as the First Asian Nation to Win the Squash World Cup Title

India achieved a **historic sporting milestone** at the **2025 Squash World Cup** by becoming the **first Asian nation to win the prestigious mixed-team title**, defeating **top-seeded Hong Kong, China 3–0** in the final held in **Chennai**. This landmark triumph marked India's **maiden appearance at the top of the Squash World Cup podium**, elevating the country's status in a sport long dominated by Western and African powers.

The Indian squad's victory was built on strong individual performances in the final. **Veteran Joshna Chinappa** provided an early lead with a composed win in the opening fixture, showcasing her experience and tactical acumen. **Abhay Singh**, India's top-ranked men's player, then extended the advantage with a decisive win. The title was clinched when **17-year-old Anahat Singh** delivered a commanding performance to secure the third match and seal India's historic clean sweep.

Earlier in the tournament, India had already made headlines by **knocking out defending champions Egypt 3-0 in the semifinals**, an achievement that marked the team's **first ever appearance in a World Cup final**. The semifinal success was built on dynamic play from national champion **Velavan Senthilkumar**, resilient matches from Anahat Singh, and clinical finishing by Abhay Singh, demonstrating depth and composure across the lineup.

The 2025 World Cup title represented a significant improvement on India's previous best, a bronze medal at the 2023 edition, and made it only the **fourth nation ever to lift the Squash World Cup trophy**, alongside Australia, England and Egypt. Indian sports fans celebrated the victory as a **defining moment** for squash in the country, highlighting the growing competitive capabilities of Indian athletes on the world stage.



The announcement came during **CEO Satya Nadella's meeting with Indian Prime Minister** in New Delhi, where both leaders emphasized the bright future of AI in India. Nadella described this investment as a strategic bet on India's vast market, talent pool, and innovation ecosystem. Further, the Prime Minister underscored **global optimism about India's leadership role in AI technology** and its potential to drive inclusive income growth and sustainable development.

UNESCO Recognizes Deepavali as Intangible Cultural Heritage

UNESCO has officially inscribed **Deepavali**, widely known as Diwali or the Festival of Lights, on its **Representative List of the Intangible Cultural Heritage of Humanity**, marking a historic milestone for India's cultural diplomacy and global heritage celebration today. The recognition was formalized under the **listing ID 02312**, acknowledging the festival's deep cultural roots, community participation, and symbolic celebration of light triumphing over darkness. Deepavali now stands on a global platform as a living tradition that transcends geographical and generational boundaries.

The UNESCO listing emphasizes Deepavali as a festival shaped by **social practices, festive expressions, knowledge systems, and shared cultural values**. Celebrated through lighting oil lamps (diyas), rangoli art, festive cleaning, exchange of sweets, prayers, and community gatherings, the festival reflects collective joy rather than a single-scripted ritual. Its transmission remains largely informal—carried forward through families, neighbourhood, and cultural participation—making it a dynamic and evolving intangible heritage.

The Ministry of Culture, Government of India, highlighted that the inscription recognizes Deepavali's **cultural diversity, inclusive spirit, and role in strengthening social harmony**. This achievement was announced during the **20th Session of the UNESCO Intergovernmental Committee** held in New Delhi, reinforcing India's commitment to safeguarding its intangible traditions. The recognition is not limited to religious significance alone but includes the festival's emotional, artistic, and community-driven dimensions that foster unity and cultural continuity.

With this inscription, Deepavali becomes India's **16th element** to receive UNESCO's intangible cultural heritage tag, joining globally recognized Indian traditions that inspire **shared cultural pride deeply**. The listing acknowledges the festival's capacity to promote **human values of compassion, togetherness, gratitude, and cultural coexistence**, which resonate universally. UNESCO further noted that such recognition supports cultural preservation while encouraging global awareness of diverse cultural expressions.
