OVERVIEW

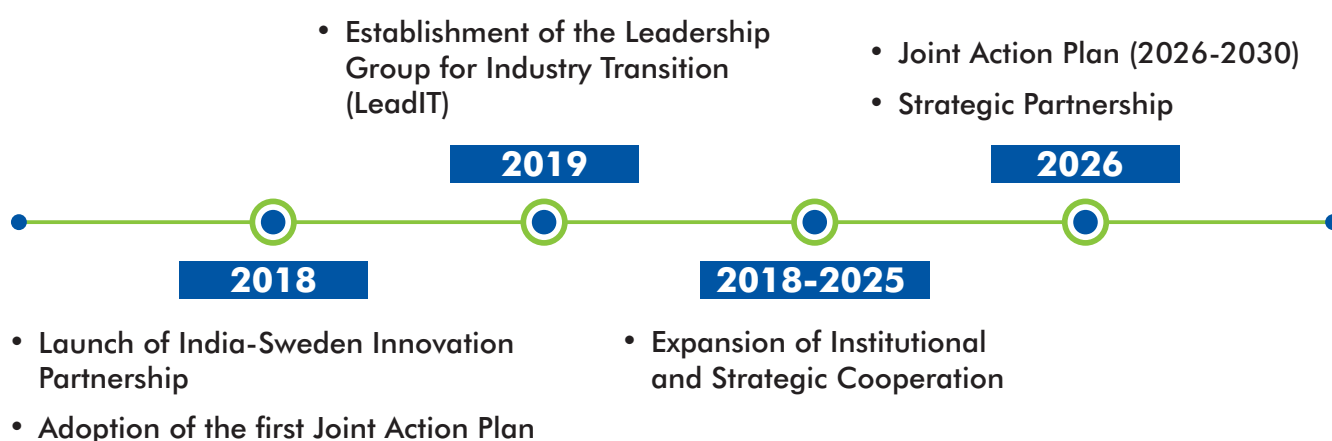

KEY PILLARS OF THE JOINT ACTION PLAN (2026-2030)

The India–Sweden Joint Action Plan (2026–2030) identifies four key pillars that define the principal areas of cooperation between the two countries. These pillars organize bilateral priorities into broad fields of engagement, enabling diverse policy objectives to be pursued through clearly identified thematic areas. Together, they establish the principal directions through which India and Sweden intend to advance cooperation during the 2026–2030 period.

The first pillar, **Strategic Dialogue for Stability and Security**, places strategic dialogue and security cooperation at the centre of bilateral engagement by providing a dedicated platform for consultations on regional, global and security-related issues. The second pillar, **A Next-Generation Economic Partnership**, establishes economic and industrial cooperation as a distinct pillar, reflecting the shared commitment of both governments to strengthening economic engagement as an integral component of the bilateral relationship.
